

BRINDISA ARTISANAL BOX COMPETITION

1. NO PURCHASE NECESSARY TO WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

2. ELIGIBILITY. The contest is open to legal residents of the United Kingdom who are at least 18 years of age as of the date of entry and who are physically located and residing in the United Kingdom.
